

**NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN**

**READ THIS FORM COMPLETELY AND CAREFULLY.**

**YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF ALL IN LINE STABLES USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM, YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM ALL IN LINE STABLES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND ALL IN LINE STABLES HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.**

**Minor Release, Waiver of Liability, Assumption of Risk, and Indemnity Agreement**

By signing this Release, Waiver of Liability, Assumption of Risk, and Indemnity Agreement (Release), I represent that I, on behalf of myself and the minor, have read this Release and that I/we fully understand the Release. By signing, I/we further acknowledge the inherent risks involved in riding and/or being in any proximity to equines, which risks include serious bodily injury, including but not limited to permanent disability, paralysis and even death, among other serious risks. Inherent risks include those dangers or conditions that are an integral part of engaging in an equine activity and include, but are not limited to the propensity of equines to behave in ways that are predictable and unpredictable such as running, bucking, biting, kicking, shying, stumbling, rearing, falling, or stepping on, that may result in an injury, harm, or death to persons on or around them; the unpredictability of equines' reactions to such things as sounds, sudden movement, and unfamiliar objects such as automobiles or machinery, persons, or other animals such as dogs and birds; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or not acting within such participant's ability. I represent that the minor is in good health and proper physical condition to participate in these equine activities. I understand that this Release is intended to include all activities whether on or off the equine, including but not limited to riding, spectating, observing, and/or interacting with equines on the ground. I/we intend this to be a complete and unconditional release of all liability to the greatest extent allowed by law which includes owners, employees, agents, officers and contract employees of All in Line Stables. I understand that this Release includes any claims based on the negligence, actions or inaction of any of the above released parties and covers bodily injury and property damage, whether suffered by my child or ward before, during, or after such participation.

I/we agree to assume all responsibility and risk related to participating in equine activities in a rider and non-rider capacity. I further agree to defend, indemnify and hold All in Line Stables harmless in the event of a suit or action against All in Line Stables with regard to claims, damages, costs or losses arising out of my or the minor's use of All in Line Stables, whether caused by my/their own negligence, misconduct, actions or inactions, the actions or inactions of others participating in any activity at All in Line Stables, the condition under which the activity takes place, the actions of an equine, or the negligence, misconduct, actions or inactions of All in Line Stables, including, but not limited to, negligent rescue or medical assistance, the condition of the facilities or of any pieces of equipment used. Because the person participating in the activity or program is a minor child, I further agree to defend, indemnify and hold All in Line Stables harmless in the event of any suit or action against All in Line Stables asserting legal rights of the minor with regard to the subject matter of this Release. I agree that I shall be solely responsible for the conduct and safety of any minors accompanying me and I shall be responsible for any damage or injury caused by such minor and I will indemnify and hold All in Line Stables harmless for any damages or injuries that result from the breach of this covenant. I further agree that if, despite this Release, I, or anyone on my behalf, makes a claim against All in Line Stables, I will indemnify, save, and hold harmless All in Line Stables from any litigation expenses, attorney fees, loss, liability, damage, or cost which All in Line Stables may incur as the result of such claim.

IN CONSIDERATION, therefore, for the privilege of entering the property of All in Line Stables the undersigned does hereby HOLD HARMLESS and INDEMNIFY All in Line Stables, and further RELEASE them from any liability or responsibility for any accident, damage, injury, or illness to the undersigned, the minor, or to any family member or spectator accompanying the Undersigned while participating in any equine activity at All in Line Stables.
