

Worker Release, Waiver of Liability, Assumption of Risk, and Indemnity Agreement

*****PLEASE CAREFULLY READ AND SIGN BELOW*****

By signing this Worker Release, Waiver of Liability, Assumption of Risk, and Indemnity Agreement (Release), I represent that I have read this Release and that I fully understand the Release. By signing, I further acknowledge the inherent risks involved in performing work or services in any proximity to equines, which risks include serious bodily injury, including but not limited to permanent disability, paralysis and even death, among other serious risks. Inherent risks include those dangers or conditions that are an integral part of engaging in an equine activity and include, but are not limited to the propensity of equines to behave in ways that are predictable and unpredictable such as running, bucking, biting, kicking, shying, stumbling, rearing, falling, or stepping on, that may result in an injury, harm, or death to persons on or around them; the unpredictability of equines' reactions to such things as sounds, sudden movement, and unfamiliar objects such as automobiles or machinery, persons, or other animals such as dogs and birds; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or not acting within such participant's ability.

I further understand that this Release is intended to include all activities whether on or off the equine, including but not limited to performing work and/or services at All in Line Stables, including operating heavy machinery such as tractors, drags, lifts, and other motorized vehicles, observing equines, performing work in the vicinity of equines, and/or interacting with equines on the ground. I intend this to be a complete and unconditional release of all liability to the greatest extent allowed by law which includes owners, employees, agents, officers and contract employees of All in Line Stables.

I agree to assume all responsibility and risk related to providing work or services at All in Line Stables, including working in proximity to equines and equine activities in a non-rider capacity. I further agree to defend, indemnify and hold All in Line Stables harmless in the event of a suit or action against All in Line Stables with regard to claims, damages, costs or losses arising out of my providing work or services at All in Line Stables, whether caused by my own negligence, misconduct, actions, or inactions. I further agree that if, despite this Release, I, or anyone on my behalf, makes a claim against All in Line Stables, I will indemnify, save, and hold harmless All in Line Stables from any litigation expenses, attorney fees, loss, liability, damage, or cost which All in Line Stables may incur as the result of such claim.

The undersigned does hereby HOLD HARMLESS and INDEMNIFY All in Line Stables, and further RELEASE it from any liability or responsibility for accident, damage, injury, or illness to the undersigned.
